**TRAVERSE CITY, MI – October 16, 2024 –** The Freshwater Roundtable is proud to announce the 17<sup>th</sup> Annual Freshwater Summit. The Summit will be held on Wednesday, October 30<sup>th</sup> from 9:00am – 3:00pm at the Hagerty Center at Northwestern Michigan College. Cost is \$40/person or \$20/student and includes lunch.

"We have another great lineup of professional speakers and look forward to discussing current challenges and opportunities facing local and regional freshwater efforts."

Presentations include aging whitefish populations and creative new restoration strategies, employing effective swimmer's itch prevention strategies to protect freshwater ecosystems, preliminary survey of microplastics in the Boardman-Ottaway River and what you can do about microplastics, and lightning talks about local initiatives. In addition to these presentations, the Freshwater Summit will conclude with a workshop on tips for talking with youth experiencing climate anxiety.
