#### I. Welcome and Introductions

# II. Recreation Plan Action Team Updates

- a. Legal framework for the river
  - i. There isn't a current pathway to pursue for the river to have its own rights due to issues related to standing.
  - ii. Next steps focus on assessing and enhancing the current regulatory environment inside the watershed and assessing policies and implementation environment outside the watershed.
  - iii. GTB Rights of Nature resolution sent to tribal council with a comment period. Questions from membership included what it means, if it limits tribal members, how it would stand up in a court of law.

### b. Healthy thriving river

- Looked at data that is currently being measured or can be collected/analyzed using existing information, as well as what that data tells us – is it a metric with standards (ex: phosphorus), an indicator of something else (ex: macroinvertebrate diversity & abundance), or a trend (ex: tree canopy change over time).
- ii. Identified 20 measurements that will help us determine the ecological health of the river. Next steps are to define the importance/relevance of each measurement, determine standards for each measurement and how these standards translate into "grades," and collect the most recent data to determine if those standards are being met.
- iii. As the ecological aspect of defining a healthy river takes shape, we need to consider how to replicate this for cultural, economic, and social health.
- c. Robust and comprehensive education program
  - i. Assessed current educational programs, identifying what education programs are currently in place.
  - ii. Began creating educational templates that include key messages about prioritizing the health of the river as it relates to the indicators/metrics identified by the healthy river action team.
  - iii. Next steps are focused on compiling a document that describes each type of river ecosystem from headwater wetlands all the way to the bay, offering in-person educational events on the river, and creating a river "academy" core curriculum about the river.

### IV. Open Forum/Announcements

- a. East Bay Township
  - i. Looking to adopt their new Zoning Ordinance on Nov. 12<sup>th</sup>; it will add a 25-foot setback for all regulated wetlands, floodplain building regulations, regulations on building on steep slopes (over 15%), prohibition on retaining walls in sensitive areas, a consistent 50-foot building/structure setback from all water bodies, enhanced vegetative buffer requirements, and an increased setback from Grand Traverse Bay from 45 to 50 feet.

### b. Green ER

- i. Hosting a showing of The Fish Thief on January 15<sup>th</sup> at 6pm at the Elk Rapids Cinema. There is no charge (donations accepted) and a discussion will follow the movie.
- c. Grand Traverse County Road Commission
  - i. Early stages of design to replace Beitner Road culverts over the river. GTCRC is evaluating pedestrian crossing under the bridge and access management around trailheads.
  - ii. Intend to address the crossing at S. Airport Road at the end of 2026.
- d. Conservation Resource Alliance
  - i. Continuing dam removals near Chums Corner on an unnamed tributary to the Boardman-Ottaway River (locally known as Apple Creek). Dam failure in 2022 led to discussion with private property owners (individual and condo association). Currently at 60% design for removal.
- e. Grand Traverse Conservation District
  - i. Welcomed Sara Vaughen to their team.
- f. Grand Traverse Band
  - i. Engaged in Black River dams (Cheboygan County), 2 aging dams up for relicensing. GTB would like to see them removed or at least find a solution to allow sturgeon upstream.
    - 1. Largest population of lake sturgeon with a harvest (6 fish) along with a streamside rearing facility.
    - 2. 2 waterfalls, 1 is the largest in the lower peninsula.
    - 3. Potential to fundraise, purchase, decommission dams.
- g. Arctic grayling initiative meeting last May announced that the decision on where grayling would be introduced would be announced this fall.
- h. Traverse City Downtown Development Authority
  - i. Lower Boardman-Ottaway River walkway will be funded even without a TIF extension.
- i. The Watershed Center
  - i. Recently received an EGLE grant to replace the culvert at 11<sup>th</sup> street where it crosses Kids Creek.
